AN ORDINANCE OF THE CITY OF PORTAGE DES SIOUX, MISSOURI, ADOPTING COUNTY ORDINANCES NO. 93-162 (ANIMAL CONTROL ORDINANCE) ANY AMENDMENTS TO THIS ORDINANCE AND AMENDMENTS THE COUNTY MAY ENACT IN THE FUTURE AND; NO. 93-178 (FEES FOR SERVICES UNDER THE ANIMAL CONTROL ORDINANCE) ANY AMENDMENTS TO THIS ORDINANCE AND AMENDMENTS THE COUNTY MAY ENACT IN THE FUTURE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PORTAGE DES SIOUX, MISSOURI, AS FOLLOWS:

## SECTION I

St. Charles County Ordinance No. 93-162 (attached) and all amendments to this ordinance including future amendments enacted and St. Charles County Ordinance No. 93-178 (attached) and all amendments to this ordinance including future amendments enacted are hereby adopted by the City of Portage Des Sioux, Missouri for the purpose of Animal Control Service and Fees for this service with the following amendments:

1) Article IV, Section 2a shall be replaced with:

Zoning Compliance. The applicant for an original kennel registration shall present to the (Deputy) Director a written statement from the Portage Des Sioux Zoning Commissioner stating that the establishment of a kennel at the proposed site is not in violation of the City of Portage Des Sioux's zoning regulations or is permissible either as a legal non-conforming use or under conditional use permit.

2) Article VI, Section 3 shall be replaced with:

Legal enforcement of this ordinance shall be the responsibility of the City of Portage Des Sioux, which may engage the services of the St. Charles County Counselor's Office by separate agreement.

## SECTION II

If any provisions of this Ordinance, or the application of such provision to particular circumstances, shall be held invalid, the remainder of this Ordinance, or the application of such provision to circumstances other than those as to which it is held invalid, shall not be affected thereby.

## SECTION III

This ordinance shall take effect and be in full force from and after its passage and approval by the Mayor and the Board of Aldermen. This ordinance has received all of the required readings at the same meeting at which the Bill is introduced, so that it can be passed at one meeting. This ordinance is prima facie, deemed an emergency ordinance because it allows the aldermen to take immediate steps to prevent or to remedy conditions or situations which are of such a nature that it demands attention and to postpone action would result in serious injury or demand to the people, the government, or the municipality. The public urgency constituting the emergency involves the preservation of the public peace, health, safety, and welfare.
