AN ORDINANCE OF THE CITY OF PORTAGE DES SIOUX, MISSOURI, RATIFYING PAST ORDINANCES OF THE CITY.

WHEREAS, The Board of Aldermen has done a systematic and careful review of all City ordinances; and

WHEREAS, The Board of Aldermen has determined that the City records contain the following ordinances: 2-9, 12, 14, 15, 16, 18-35, 40, 41, 50, 51, 53-93, 101-141, 150, 152-232, 233-243, 245, 246-261

WHEREAS, It is the desire of the Board of Aldermen to ratify all of the above ordinances; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PORTAGE DES SIOUX, MISSOURI, AS FOLLOWS;

SECTION I

ALL OF THE ORDINANCES CITED ABOVE, PLUS RESOLUTIONS, ORDERS AND REGULATIONS AT THE TIME OF THIS ORDINANCE SHALL REMAIN AND BE IN FORCE UNTIL ALTERED, MODIFIED, OR REPEALED.

SECTION II

ALL JUDICIAL PROCEEDINGS OF ANY KIND OR CHARACTER AND ALL CONDEMNATION PROCEEDINGS FOR THE TAKING OR DAMAGING OF PRIVATE PROPERTY FOR PUBLIC USE, AND ALL PROCEEDINGS TO INCUR DEBT AND ISSUE BONDS BEGUN OR PENDING, AND ALL CONTRACTS FOR THE DOING OF ANY KIND OF PUBLIC WORKS NOT COMPLETED AND PERFORMED SHALL IN NO WISE BE AFFECTED; BUT THE SAME MAY BE COMPLETED IN EVERY RESPECT AS NEARLY AS MAY BE IN ACCORDANCE WITH THE LAW.

SECTION III

ALL RIGHTS OF ACTION, CONTRACTS, TITLES, FINES, PENALTIES, AND FORFEITURES ACCRUED TO AND IN FAVOR OF THE CITY OR AGAINST THE CITY SHALL REMAIN IN EXISTENCE AND IN FULL FORCE AND EFFECT AS FULLY IN EVERY RESPECT AS IF THIS ORDINANCE HAD NOT TAKEN EFFECT. ALL RECOGNIZANCES AND CONTRACTS LAWFULLY ENTERED INTO OR EXECUTED BY OR TO THE CITY AND THE LIEN THEREOF, AND ALL WRITS, PROSECUTIONS, ACTIONS AND USES OF ACTION SHALL CONTINUE AND REMAIN UNAFFECTED.

SECTION IV

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FULL FORCE FROM AND AFTER ITS PASSAGE AND APPROVAL BY THE MAYOR AND THE BOARD OF ALDERMEN.
