AN ORDINANCE OF THE CITY OF PORTAGE DES SIOUX, MISSOURI, ADDING STOP SIGNS AT INTERSECTIONS WITHIN THE CITY, AN ORDINANCE PROVIDING FOR AMENDING STOP SIGN ORDINANCES ALREADY IN FORCE IN THE CITY OF PORTAGE DES SIOUX, MISSOURI.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PORTAGE DES SIOUX, MISSOURI AS FOLLOWS:

SECTION I

A major stop sign shall be established at the intersection of Commonfield and Lewis Streets. All traffic coming north on Lewis Street shall come to a complete stop upon reaching said sign at the intersection of Commonfield and Lewis Streets.

SECTION II

A major stop sign shall be established at the intersection at Commonfield Street and Dumond Streets. All traffic coming east or west on Commonfield shall come to a complete stop upon reaching said signs at the intersection of Commonfield and Dumond Streets. This now becomes a three way stop.

SECTION III

A major stop sign shall be established at the intersection of LeClaire and Second Streets. All traffic coming east or west on Second Street shall come to a complete stop upon reaching said signs at the intersection of LeClaire and Second Streets. This now becomes a three way stop.

SECTION IV

A major stop sign shall be established on Clark Street going north at Second Street. All traffic coming north on Clark Street shall come to a complete stop upon reaching said sign at the intersection of Clark and Second Streets. (Yield sign to be removed.)

SECTION V

A major stop shall be established on Dumond Street going north at Main Street. All traffic coming north on Dumond Street shall come to a complete stop upon reaching said sign at the intersection of Dumond and Main Streets.

SECTION VI

A major stop shall be established on Dumond Street going north and south at Second Street. All traffic coming north or south on Dumond Street shall come to a complete stop upon raching said sign at the intersection of Dumond and Second Streets.

SECTION VII

If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid by any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

SECTION VIII

All ordinances or parts of ordinances conflicting with this ordinance are hereby revoked.

SECTION IX

This ordinance shall take effect and be in full force from and after its passage and approval by the Mayor and the Board of Aldermen.
